
Dear Gene:

POCKET LAWYER OF LEGAL FIRST AID

This pocket lawyer is provided as a means of keeping black people up to date on their rights. We are always the first to be arrested and the racist police forces are constantly trying to pretend that rights are extended equally to all people. Until we arm ourselves to righteously take care of our own, the pocket lawyer is what is happening.

1. If you are stopped and/or arrested by the police, you may remain silent; you do not have to answer any questions about alleged crimes, you should provide your name and address only if requested (although it is not absolutely clear that you must do so.) But then do so, and at all times remember the fifth amendment.

2. If a police officer is not in uniform, ask him to show his identification. He has no authority over you unless he properly identifies himself. Beware of persons posing as police officers. Always get his badge number and his name.

3. Police have no right to search your car or your home unless they have a search warrant,

your consent. They may conduct no exploratory search, that is, one for evidence of crime generally or for evidence of a crime unconnected with the one you are being questioned about. (Thus, a stop for an auto violation does not give the right to search the auto.) Your are not required to tonsent to a search; therefore, you should not consent and should state clearly and unequivocally that you do not consent, in front of witnesses if possible. If you do not consent, the police will have the burden in court of showing probably cause. Arrest may be corrected later.

4. You may not resist arrest forcibly or by going limp, even if you are innocent. To do so is a separate \$\psi \mathbb{K}\$ crime of which you can be convicted even if you are acquitted of the original charge. Do not resist arrest under any circumstances.


5. If you are stopped and/or arrested, the police may search you by patting you on the outside of your  $\phi t/f\phi t/f//$  clothing. You can be stripped of your personal possessions. Do not carry anything that includes the name of your employer or friends.

6. Do not engage in "friendly" conversation with officers on the way to or at the station. Once you are arrested, there is little likelihood that anything you say will get you released.

- 7. As soon as you have been booked, you have the right to complete at least two phone calls: 1) to a relative, friend or attorney, 2) to a bail bondsman. If you can , call the Black Panther Party, 427-9693, the Party will post bail if possible.
- 8. You must be allowed to hire and see an attorney immediately.
- 9. You do not have to give any statement to the police, nor do you have to sign any statement you must give them, and therefore, you should not sign anything. Take the fifth and Fourteenth Amend ment, because you cannot be forced to testify against yourself.
- 10. You must be allowed to post bail in most cases, but you must be able to pay the bail bondsmen fee. If you cannot pay the fee, you may ask the judge to release you from custody without bail or to lower your bail, but he does not have to do so.
- 11. The police must bring you into court or release you within 72 hours after your arrest (un-less the time ends on a week-end or a holiday) and they must bring you before a judge the first day court is in session.
- 12. If you do not have the money to hire an attorney, immediately ask the police to get you an attorney without charge.

## PRESS STATEMENT

THE FASCIST PIGS HAVE MOVED ONCE AGAIN TO DESTROY THE BLACK PANTHER PARTY AND ITS STRUGGLE FOR LIBERATION OF BLACK PEOPLE, AND ALL OPPRESSED AND EXPLOITED PEOPLE. ON THURSDAY, AUGUST 7, 1969, AFTER HAVING ATTENDED A "HIROSHIMA DAY RALLY". FIVE MEMBERS OF THE BLACK PANTHER PARTY'S BOSTON. CHAPTER, INCLUDING THE DEFENSE CAPTAIN, DOUGLAS MIRANDA, WERE ARRESTED IN NEW HAVEN, CONNETICUT SUPPOSEDLY FOR INTER-STATE TRAVEL IN A STOLEN MOTOR VEHICLE AND CONSPIRACY TO DO THE SAME FROM CONNECTICUT TO MASSACHUSETTS. THEY ARE PLACED UNDER A RANSOM OF \$142,500. IDA WALSTON, MOTHER OF FOUR, WAS PLACED ON \$100,000 RANSOM. THIS CRIME OF KIDNAPPING BY THIS FASCIST GOVERNMENT WILL NOT GO UNHEEDED BY THE PEOPLE. THE NEW YORK 21, BUSTED ON APRIL 3, 1969, FOR CONSPIRACY TO BLOW UP A DEPARTMENT STORE, PIG STATION, AND TULIPS ( THE BRONX BOTANICAL GARDENS), WILL NOT BE FORGOTTEN:; THE CONNETICUT 8, KIDNAPPED FOR THE MURDER OF ALEX RACKLEY, WHO THE PIGS KILLED, AND CONSPIRACY TO COMMIT MURDER, WILL NOT BE FORGOTTEN; HUEY P. NEWTON, MINISTER OF DEFENSE OF THE BLACK PANTHER PARTY, INCARCERATED FOR BRINGING THE TRUTH TO THE MASSES OF POOR AND OPPRESSED PEOPLE, WILL NOT BE FORGOTTEN; NOR WILL ANY REVOLUTIONARY BE FORGOTTEN BECAUSE YOU CAN JAIL A REVOLUTIONARY BUT YOU CANNOT JAIL A REVOLUTION; YOU CAN JAIL A LIBERATOR, BUT YOU CANNOT JAIL LIBERATION. THE IDEA OF REVOLUTION IS INVESTED IN THE MASSES OF PEOPLE BECAUSE THE RULING CLASS IS WILLING TO LIVE IN LUXURY AT THE EXPENSE OF THE OPPRESSED WORKING CLASS OF PEOPLE. BUT THE PEOPLE WILL NOT LET OUR BROTHERS AND SISTERS CONTINUE TO BE ENTOMBED IN THE STENCH OF AMERICA'S JAILS AND PRISONS. THE PEOPLE UNDERSTAND THAT WE ARE IN THEIR SERVICE. WE HAVE PROGRAMS THAT CATER TO THEIR BASIC MATERIAL NEEDS. THE BLACK PANTHER PARTY IS AN OXEN TO BE RIDDEN BY THE PEOPLE AND WE HAVE TRULY PROVEN OURSELVES TO BE THE VANGUARD OF THE PEOPLE.

The struggle by this capitalistic, racist society to repress the revolutionary movement of the poor and oppressed masses has been intensified. Any people or organizations of people which has aligned itself with the people has suffered an attack by this fascist American society--- A New Germany---- and by the reactionary slogans of "Law and Order" by the lying, deceiving politicains who seek only to perpetuate their systems of oppression and exploitation of black people in particular and the American people in general.

The determination of all revolutionary peoples and revolutionary organizations to educate the poor and oppressed masses to the true nature of this decadent American society has been repressed. Remember Medgar Evers and Martin Luther King who were moderates, yet were a step to being revolutionaries, Malcolm X, Huey P.
