POLITICAL PRISONERS SOUTHERN CALIFORNIA

ARTHUR LEAGUE...recently convicted in racist Orange County, Santa Ana California. Now facing a five to life sentence for allegedly killing the "Rookie Pig of the Year". He was charged originally with first degree murder. But after nine days of de-liberation an 'all-white' jury 'compromised' on a second-degree verdict. His case is currently being appealed in the state supreme court. Arthur who organized in Santa Ana before being kidnapped by the pigs there, was remanded to Chino Prison to await final placing in a state institution.

LUXEY IRVIN AND ROBERT WILLIAMS... were convicted by an 'all white' jury in the lily-white suburb of Torrance Attempts by their attorneys for a change of venue were denied. The brothers were convicted (along with Romaine 'Chip' Fitzgerald) of several counts of assault on a pig, kidnap and other trumped-up charges. Several consecutive sentences have it certain they'll have to face life in prison. Chip, the third brother, because he had been given the death sentence in another frame-up, was given a sentence of one to ten years...Robert and Luxey

are also in Chino Prison, awaiting shipment to state pig pens. They must endure 24-hour lock up (they refuse to work) and are only allowed two or three hours of exercise per day. The constant harassment hasn't daunted their revolutionary spirits, and they continue to make known the political ideology of the Vanguard Party through classes held with other brothers in this pig pen.

ROMAINE FITZGERALD...known affectionately as 'Chip' is now on death row in San Quentin State Prison. This brother was railroaded by a raci lawyer and jury who all agreed this Panther should be sentenced to the ga chamber after a 'mock' four day trial Chip was sent to San Quentin immediat ly to make it difficult for his famil to visit and communicate with him. Proving again the spirit is truly greater than the contempt of pigs, the Party moved to send Chip's mother and family, as often as they can make the trip to see the brother in order to keep his spirits high. Chip is just one of the many strong brothers who have faced repeated attempts of genocide by the fascist pigs here in L.A. Before being arrested on this trumped up charge, Chip was constantly stopped and harassed by the pigs in L.A. for no other reason than serving the peo-

ple. He now awaits appeal, and does so with the knowledge that victory and liberation, in the final analysis, belong to the people.

ROGER 'BLUE' LEWIS...has been the victim of repeated attempts to kill or imprison him. Blue since joining the Party has had to fight six times for his life and was acquitted six times. He has been in the fascist pigpen of New County since being kidnapped last August, almost a year ago. During this time his probation was violated on the pretense that he didn't get permission to leave the State when he was called to visit his sick father. He may now have to serve one to ten years if an appeal is not granted.

In addition, the brother still faces three major charges. He now awaits trial in a bomb case where he supposedly was riding around the city of Los Angeles (along with the Southern California Chapter Deputy Minister of Defense, Geronimo) with 'pipe bombs' in the car...The pigs are moving full steam ahead to attempt to file charge after charge to make sure he along with our other political prisoners is behind bars for life...The second major case is

an attempt to frame Blue along with three other members of the So. Calif. Chapter in a 'bizarre conspiracy' to kidnap and beat a 16 year old boy. The ridiculous nature of the charge is indicative of the desperateness of the LAPD to jail the Panthers here.


Blue is a prime example of the pigs attempt of 'legal genocide'. Although he's been acquitted at least six times in attempts to put him back in their pig pen, Blue is still harassed by his 'so-called' record. TRIAL OF DETROIT 15 COMES TO A CLOSE

On October 24, 1970, 15 members of the Black Panther Party were arrested and charged with the murder of a Detroit policeman, Glenn Smith. At the time of their arrest they were attacked by a police raiding party. There was firing into and around a house for 9 hours from which the fifteen brothers and sisters were finally driven out by tear gas. The last three being Erone De Soussure, Benjamin Fondrun and David Johnson, who were eventually found guilty of felonious assault on the raiding police officers.

In May of this year, all 15 of them were brought to trial not only for the murder of Glenn Smith, who was supposedly ambushed that same day, but also for conspiracy with the intent to commit murder of the 40 policemen that surrounded the Detroit Community Center, back in October.

Throughout the country the agents of the law always want us to believe that it is the people who are provoking the attacks on them. It seems to be a constant pattern that the police unwarantedly harass and attack the People, particularly Black Panther Party members and then scream that they have been shot at, ambushed, that they are the victims of unprovoked attack. We know this to be untrue. As a matter of fact, we understand that the work we do in the communities of America is geared toward the survival of poor, Black people and therefore threatens

their existence. Our programs serve the people's interests by providing basic necessities, food, health care, clothing, etc. The government understands that through our own programs people will unify against oppression. They realize that if we work together to survive, we can organize to control our own lives. They fear unity in the communities because this means disunity within their crumbling structure and their eventual downfall.

It was not until the free breakfast for school children programs were established across the country that they began to openly attack our Community Centers and homes in full force. From the murder of Fred Hampton to the attack on the centers in L.A. to the raids and attacks on our community centers in New Orleans and elsewhere. No one ambushed them in Detroit, as they claim; they at-

tempted to ambush our Detroit Chapter and herd them off to the prison camps to be railroaded through the courts. The trial of members of the Detroit Branch of the Black Panther Party lasted for six weeks. Sevendays were spent picking the jury, which consisted of ten Blacks and two whites. The prosecution built its whole case around one of the defendants, John Lee, whom they singled out as the only person who could place a weapon in the hand of one of the other defendants. They felt that if they dropped all charges against him, he would testify (lie) for the State. So they dropped the charges against him. When The state of the s

John Lee was called to the stand, he refused to testify. He was the only

one who could, according to the prosecution, prove that the shot that killed Officer Glenn Smith came from the community center. Lee refused to utter a word. The judge cited him with contempt of court. They sentenced him to 30 days in jail for refusing to testify. And still no word.

These trumped-up charges for this case were therefore left in the air again. So that when the jurors deliberated, for thirty hours over a fiveday period, they felt that there was not enough evidence to convict the defendants of murder. However, because of the forcefully skillful manner in which the prosecution implicated Brothers De Soussure, Fondrun and Johnson, the jurors wished to convict them of something, Mrs. Angeline Buchanan was the only juror who held out, for 2 1/2 days, however, because she felt that there was no evidence to convict any of the defendants on any charges.

In an interview with Mrs. Buchanan, she stated that they (the other jurors) became hostile and threatened her if she did not make a decision. She finally did - guilty. However, if it had not been for her firm stand on an acquittal for all, the charges would never have been dropped down to felonious assault for those three brothers. The acquittal for nine and lesser charges for three was the jury's compromise.

ON THE ACQUITTAL OF THE NEW YORK TWENTY-ONE AND THE HARLEM FIVE

STATEMENT OF ATTORNEY GERALD LEFCOURT, ATTORNEY FOR THE NEW YORK TWENTY-ONE

A new morning has come. With it a new ideology has invaded New York City and perhaps elsewhere as well. The "2l" Victory indicates that a cross section of people reject the tactics of secret police, the undefinable law of conspiracy used as a trap, biased judges and over-zealous prosecutors.

With thirteen defendants, each charged with twelve different crimes, the courtroom broke into hysteria when the Black jury foreman rose and said, "Not guilty, not guilty..." one hundred fifty-six times. With one fell swoop New York was ignited in a people's celebration. Not at the prospect that the "American system of justice" works, but rather at the prospect that when you fight hard enough and struggle long enough, your cause, if it is just and true, will be answered.

One juror said he felt like running up to Judge Murtaugh and asking him where he thought he was "Mississippi?". Another said, "Conspiracy law is like a lasso that is turned into a hangman's noose that fits every collar size." Still another said, "This verdict of not guilty was necessary for everyone's freedom". All in all, twelve people with their four alternate jurors, unanimously agreed that the verdict was "Not guilty" on every charge. Without any disagreement at all, the jury ended the longest trial in the history of New York with a 90-minute deliberation.

history of New York with a 90-minute deliberation. Way back on April 2, 1969, the government launched its attacks with the indictment of the "21", following soon thereafter with the indictment of the "Chicago 8", then in May, 1969, the New Haven Chapter of the Black Panther Party was indicted for murder, and in a phony hunt for George Sams, the government attacked and destroyed offices of the Black Panther Party in several cities across the nation and finally indicted Bobby Seale also for murder in Connecticut. These attacks culminated in the murder of Fred Hampton and Mark Clark on December 4, 1969, in Chicago, Illinois. Besides Ericka and Bobby, Angela Davis and Ruchell Magee, the Berrigans, in Harrisburg, and countless others around the nation, the government has been attacking ever since.

The verdict in the New York 2l case is the first step in the fight back, hopefully to be followed quickly by a victory for Ericka and Bobby and on to victory in California for Angela and Ruchell. In each case, the fight back will continue to prove that through struggle and determination and the support of the people, freedom can be a reality for those who seek it hard enough.

STATEMENT OF ATTORNEY WILLIAM KUNTSLER, ATTORNEY FOR THE HARLEM FIVE

The acquittal of the New York 21 and the Harlem 5 c spurious conspiracy charges raises sharply the issue of the criminal conduct of public officials. Many Black an some White people have recognized for years thatthe judicial process has been illegally used, since the ver foundation of the Republic, to punish political dissidents to crush liberation movements and to control the pool Now, for virtually the first time in American History those who wanted so much to believe in the fairness of the system can see at close range that the concept of equipustice under law was merely a convenient smokescree for the power structure's consistent and relentless destruction of human rights and liberties.

It would be ironic indeed if the New York acquittal were viewed as proof that the system does indeed work Nothing could be further from the truth. It was the system that arrested, indicted and tried these Black defendant. It was the system that stripped from them years of the lives, unmercifully and unjustifiably punished their families and attempted to ostracize them from human societ. It was the system which, in total disregard of all of i most vaunted principles of justice and fair play, tried brutalize and destroy them.

That they were eventually saved is a triumph, not of destructive system, but of two juries which, at lon last, could not bring themselves to legitimatize the tranny of the law. These verdicts represent, in a microsom, the revolt of the powerless from the fearful con mands of those who seek to control and direct the destinies of all of us. Twenty-four Americans decided, the face of a monstrous evil, to cry halt to those wattempt to equate court decrees with the hangman's noo and the headsman's blade.

These cases do not mark the beginning of the Gold Age of Universal Justice. But they do give heart to us and indicate that some fights can be won if we are t gether with ourselves and determine to resist oppressiuntil we destroy it or die in the process. And, hopeful they will teach other juries in other places that there truth to the cries of the persecuted and that the syste will often stoop to the pavement in order to preser itself and its mythology.

We must now go forward on every front in unity a comradeship. Our true enemies are not ourselves, I those who lie in wait for each of us - the power hung the avaricious, the hate mongers, the militarists, the i perialists, the racists, the despoilers of the dream. O brothers and sisters may die, but they will not be de troyed - their hopes and dreams will be passed fro willing hand to willing hand until the walls come down a the city is ours. Then, and only then, will the time ha been seized and the power re-taken by the people.



BROTHER: Not to anyone in par-ticular, because I think, that every-one of them represents an indi-vidual who has done what he thinks he could do and has put forth a whole lot of effort to accom-plish what he believed in. And I have to appreciate all of them, I do appreciate all of them. They have their own different ways of

going about doing things, but they all have to be appreciated because they have given up a lot. Con-sidering they are in exile, in jail or what have you.

PIGS ATTACK TOLEDO NCCF

This press conference is being called by the Toledo, N.C.C.F. to publicly denounce the victous atupon the Toledo N.C.C.F. Headquarters, as being unprovoked and highly fascist in nature. The local and national conspiracy to kill or jail members of so-called organizations has finally reached its deadly tentacles into our com-munity with hopes to steal our munity with hopes to steal our quest for freedom, but this cannot and will not be done.

The incidents surrounding these

vicious attacks are as follows: 1. The passing of an ordinance sponsored by Mayor Ensign Deputy Chief Duck, Safety Director Quinn, and Chief Bosch which states that it is unlawful for any citizen to call a policeman apig or make oink -

The passing of this ordinance

is a direct violation of the people's Constitutional Right of Freedom of Speech and expression whereas Black people have been called 'Niggers' by Toledo's racist policemen, and nothing has ever been done to stop their offen-sive language and exploitations against Black people.

2. Another incident is over policing and police brutality which has run rampant throughout the Black colonies. The over policing and brutality in our Black communi-ties has allenated Black people and policemen and Black people see policemen as occupying troops and a threat to their freedom. The James Dotson incident is a prime example of the brutalir Black people must face. This man vas maced, handcuffed, and then beaten. Then when the Docson family went to the Safety Building to inquire of their loved, they were

verbally and physically abused. To verbally and physically abused. To the Dotson family, the Toledo N.C.C.F., and all revolutionary people say - RIGHT ON! 3. The climax of the incidents leading to the attack on the

N.C.C.F. Headquarters was the fa-tal shooting of Policeman William Miscannon, This incident was used to attack the Headquarters and also as an excuse to send John Mc-Clellan to the electric chair, and to send Mike Cross to the penitentiary. In the news, patrolman Miscannon was portraved as a "good cop," but he was known for his racism and acts of brutality throughout the Black com-munity. His partner in crime against the people, Walter Shaw, who in the eyes of the people is a lackey, a bootlicker, and a traitor who shot me, Larry Mc-Clellan, as I was trying to surren-Clellan, as I was trying to surren-der with my hands up, and he was one of the many who shot Troy Montgomery, who was also sur-rendering with his hands up, and both were unarmed. Shaw also opened fire on Mike Cross as he tried to surrender, empty-handed. The news media failed to mention that Troy laid on the wet sidewalk with the rain falling on him for over two hours. After Troy was taken to the hospital he lay for another two hours before treat-

ment began.
We will not have John McClellan tried and convicted by the press as in the case of Clarence Squaire ere the suspect was convicted before he ever got to trial. State-ments such as the one made by Mayor Ensign saying that Brother John McClellan is a depraved per-son, must cease, or there can be no fair trial anywhere in the

United States. We will not have Mike Cross jailed for a so-called long gun violation, or possession of explosives. The explosives were obviously a plant because they were not discovered in the immediate search of the building, but when Brother Cross voluntarily accompanied them in another search of the building.

Contrary to what the administration may believe, they have not stilled our efforts, we will intensify our struggle for total and un-

NOT GUILTY! THE SANTA ANA 1

The reactionary, racist, fascistic Santa Ana Pig Dept. is continuing their kangaroo court proceedings against the Santa Ana One - Daniel Michael Lynem, He was to be brought forthfor preliminary hearing, motions for discovery of evidence and the return of his 11-legally obtained property. Court proceedings were to begin at 10:00 a.m., Monday Morning, June 16. Preceedings were delayed by various bureaucratic methods until 11:45 a.m. The Judge, an obvious recruit from some 200, then announced that the preliminary hearing was dismissed, and that Mi-

recruit from some zoo, then amounced that the preliminary hearing was dismissed, and that Michael has just been secretly indicted for murder by the Santa Ana Grand Jury.

The D.A. realized that he would have to present his non-existent evidence at the scheduled preliminary hearing (which is open to the public), so he made the strategic move of having the preliminary dismissed and a secret indictment handed down to save face and to maintain the trumped-up charges.

The 42 people who were able to squeeze into the small courtroom went into an uproar. The approximately 150 persons unable to get into the courtroom were outside petitioning for a larger courtroom.

into the controom were outside petitioning for a larger courtroom. This combined group then moved on the newmen outside who were badgering Michael's father and wife for statements and answers to questions.

Panthers who had been unable to get into the courtroom were politicizing and selling papers. The people responded with many questions about Fascism, and the Pigs responded with concrete examples. Previously, various members of the Los Angeles and Santa Ana Branches of the Black Panther Party had been picked up and harassed (and one beaten) on suspicion of murder in connection with the Santa Ana case. Also, Panthers picion of murder in connection with the Santa Ana case. Also, Panthers from L. A. who have been attending from thearings in Santa Ana have been stopped for no reason every time they have been in Santa Ana. They have had Panthers' Legal Defense literature, materials and time they have been in Santa Ana. They have had Panthers' Legal Defense literature, materials and information taken and photographed without legal warrants of any kind. The people knew of these incidents and remembered them when we appeared at the courtroom. This has helped to bulld up the understanding and support of the community, particularly for Michael and the Panthers for the insane treatment we have received from the pigs under the guise of law and order. Michael's trial date has been set for July 21, 1969. Panther captain murdered

LOS ANGELES, Dec. 30—Franko Diggs, a captain of the Los Angeles Black Panther Party, was murdered at 120 St. and Main St. on Dec. 19, according to a statement made today by Panther spokesman Mike Pennywell. The murder received no coverage in the local newspapers. A public funeral was planned for 1 p.m., Thursday, Jan. 2, at the Victory Baptist Church, 4802 McKinley Avenue.

In a statement to The Militant, Pennywell described the murder of Franko Diggs as "an attempt to liquidate the leadership of the Black Panther Party by the racist power structure. . . . Captain Franko had no real family—but he had a big family here in L.A. that loved him very deeply, the Black Panther Party. . . . We will intensify our struggle until there will be no more cold-blooded murders of our people."

BROTHERS SENTENCED TO SIXTY DAYS FOR SELLING NEWSPAPERS

Friday, September 11, marked new epoch in political repression. The pigs have repeatedly attempted to squash our political organ, the Black Panther Community News Service. Their meon a national level is to subpoena Panthers who are known to work on the Black Panther, the nationwide Black Community News Service to testify before the Grand

In Los Angeles this repression has been and continues to be manifested in repeated arrests of Pancommunity workers while selling our paper throughout the community. In the past months, the majority of our misdemeanor cases involved Panthers and community workers selling papers. In all cases, pigs have charged them not with selling our paper, but violations like disturbing the peace, interfering, and occasionally, when a pig moves physically on a brother, misdemeanor batter.

In our attempts to exhaust all legal means to expose the contra dictions in the antiquated laws and the racism inherent in the due pro-cess syndrome, we've taken all such cases to court, always mindful of the consequences in the event of a guilty verdict. Friday was such a day...the pigs gloatingly participated in the sentencing of three brothers for "interfering". They were found guilty of inter fering with each other's arrest selling papers. Their attorney Dan I und, argued fifteen minutes to no avail to have approximately 15-20 pigs removed from the courtroom and to refrain them from disrupting his attempts to argue for an appeal. The fascist indee denied his motion. Bernard Smith and Ronnie Hawkins (arrested several times previously) were sentenced to sixty days in the county jail and placed on a year probation. "Omar William Gordon, because he's a brother from the community and was employed...was sentenced to

years probation. The terms of the probation expose the true intentions of the court not to administer justice or any of that euphemistic idealism of justice and fair play in the courts that people are constantly being insulted with, but to repress both physically and politi-cally anyone who attempts to expose the decadence of this corroding society. Each of the brothers is to find employment and maintain a job...obey all laws...is not to invade the Black community to be affiliated with any organization or group advocating the violent necessary. Certain pre-designated overthrow of the government...and people who because of their my-lastly, not to be caught selling papers, magazines, or the like withtain a job...obey all laws...is not to be affiliated with any organizapers, magazines, or the like with-peoples just struggle for libera-in a hundred feet of anyone else. Nothing else really needs to be said, it's clear the intentions of the pigs are to wipe out all traces of political activity, no matter what it takes. If they can harass anyone affiliated with the Party they mistakenly assume the organization is weakened. It should be clear after many such attempts that just the site is in fact true. Each act harassment, each attempt to violate and nullify the works of a Panther by arrest and jailing in-creases the determination of eir comrades to hasten the efforts being made to deal with the corruptness and decadence of this seat of imperialism. To be a political prisoner is merely a testimony of an individual's attempts to take part in the overall struggle of our people against the forces that oppress us.

The education and practice of brothers like Bernard, Ronnie, and Ornar will prove that you can jall a revolutionary but not his ideas or the ideas of a people who must bring about this change. "You can jail a revolutionary but you can't jail a revolution."

On Friday, Sept. 11, at about 2p.m., comrade Bill Green had been as-signed to sell papers on a busy signed to sell papers on a busy intersection, on 23rd & Union located in the heart of the Black colony, with a right-on community worker Robert Reiggs. While talking and selling papers to the people brother noticed that a couple of were checking them out. A little later, the same two pigs got out of their car, approached Robert and asked him if he would get in the car so they could give him a ticket for stepping in the street. Robert said that he would consider accepting a ticket but he didn't think it was necessary to step in their car, which would be giving them the opportunity to wisk him quietly off to the dungeon. The pigs then proceeded to grab Robert and attempted to handcuff him. While one pig grabbed one arm the other pig attempted to grab his other arm and was knocked down by Robert who realized it was time for him to defend himself. When Bill Green attempted to come to Robert's aid, ten more sadistic pigs led by a black bootlicking lacky pig jumped on both of the brothers, handcuffed them took them off to jail, as yet there were no charges.

By this time members of the com munity had informed our office and we headed for the city dungeon. Our lawyer, John Coughlon, met us there and he went inside to talk to Bill and Robert. Inside a pig guard told John that he had better talk to his clients and tell them to answer some questions or else he would see to it that neither of them got out even if bail was posted. John replied that his clients constitutional rights under the fifth amendment would not be denied and that Robert and Bill would be set free. We then found out that Robert had been charged with 1) soliciting business in a prohibited area 2) arrest 3) concealed Bill was charged with resisting weapon. interferring with an officer. These charges show that it was clearly harrassment of the people's serv-

Where is the right to freedom of press when our comrades are snatched from the streets while selling the Panther Paper. It is also interesting to note that this particular Issue which Bill and Robert were selling contained Huey's message to the Revolutionary Peoples Constitutional Convention. The rights of the people are continuously violated everyday. The need for a new constitution is urgent and with the people responding readily to this the pigs will go to any lengths to stop us from getting this information to the people by any means neces-sary. We realize that these sad-istic pigs are escalating their attacks against the vanguard to keep us from educating the masses, but this will make us continue to strug-gle even harder to destroy this evi corrupt government which perpetuates this sick society of capitalism
