The major indictments returned The major indictments returned by the Cook Coissity Grand Jury against the Black Panther Party were a concerted effort by the federal government to destroy the leadership of the people's vanguard. But like their efforts in the past, these reactionaries have proven themselves to be paper tigers. The fasuist pigs have reactionabled their attempts to device the doubled their attempts to destroy the Party since their frame-up of Deputy Chairman Fred Hampton falled to stop the Party and its

The Justice Department and its agents are trying desperately to keep the truth from the people, Deputy Chairman Fred Hampton has been transferred from Statesville penitentiary to Menard penitentiary. The federal government neither notified his attorneys nor his family of the transferral June

his family of the transferral June 3rd. The government still refuses to accept his motions for a new trial and appeal bood.

The mindight indistments against the sixteen Panthers were immediately followed by the issuance of arrest warrants. The attorneys were not allowed to see their cilents until the boos reduction hearings and information that was occessary to support the please for bood reduction was withheld. The Black Fanther Party has become the target of a growing nationwide campaign to cripple the operations in Chicago and other

operations in Chicago and other major cities, The Justice Depart-ment in Chicago admits that there had been concerted "FEI activity and investigation" with regard to the Black Parither Party. The fod-eral pize have given the order to

unleash the repression against the fillinois Chapter in order to stop the mass movement and its pro-grams to aid the oppressed peo-

The indictments followed the arrest of 11 Fanthers on Sanday, June 8th. The Fanthers were stopped in their car by facelet pigs. They were ordered out, searched, and physically absoed. The car was searched without a warrant. The pigs then planted marijuans in the car. The Fanthers, who are forbidden to carry marijuans in their possession were later charged with possession of marijuans and released on \$1,000 bond. in the maternity ward of the Cook County Hospital. On June 4th at 5:00 in the morning, 500 fascist pigs cornered off a 5 block area surrounding the office. Federal marshalls, FBI agents, and local pigs armed with agenta, and local pign armed with machine guzs, heavy weapons, bul-let-proof vents, and a belicopter raided the office. Eight members of the Black Panther Party were arrested and charged with "har-boring a fugilie" that the pig-nover found. Following the arrests, flactist wrocking crews armed with hatchets went to work to destroy the office. All conjugues and figthe office, All equipment and fix-tures were either stolen or de-stroyed beyond repair, force of the money was to buy food for the

Breakfast for Children Program and the establishment of a free medical center for the people of the community. Dannage to the office was estimated at \$20,000.

The federal pigs have falled once again to destroy the Party. They have only rekindled our efforts, We will surmount every obstacle placed in our path and forge close links with the masses. We will make the masses understand that "without the peoples army, the people have nothing."

FASCIST PIGS ATTACK PREGNANT SISTER

Sunday evening about 8:15 p.m., about 12 blocks from the office. Six (6) brothers and five (5) sisters left (6) In others and five (3) sisters left the office about 8:00 p.m. on their way to see a Chicago film concerning the Panthers, They noticed they were being followed and turned a corner to stop for a second. Task force and pig cars converged on the car. People in the community started to come out to find out what was going on. The people knew they were Panthers and started to attack the pigs and thrustseed to accome out with their pieces; the pigs. attack the pigs and threatened to come out with their pieces; the pigs then moved the brothers and slaters into waiting paddy wagoons and police cars before an "inci-dent broke out". The Panthers pro-ceded to pass out literature while key were being arrested, The pigs said before they left the scene that the bothers are distorted. that the brothers and staters would be charged with possession of chemical explosives and inciting a riot. The Panthers were then taken to the pig station where they were held for at least 5 hours before the

could find a charge to place on them. Shortly after Ann Campbell and I arrived at the pig station to get the people out, I saked the pig what the charges were and the pig what the charges were and the pig told me they didn't know yet, itold the pig that they could not hold the pig that they could not hold the brothers and sisters if they didn't have a charge. Ann and I immediately moved to phone the lawyers, About that time the slaters in the lock-up had started to conduct a political education conduct a political education to conduct a political education class and the people in the lock-up started talking and the pigs said they were causing confusion and said they had to be moved. I saw the pigs bringing out Andrea Graves with her hands handeuffed behind her back, They pushed her and the rost of the sisters into another room. Sandra Rich - nine-tees (19) conserved. another room, sandra Hich - mine-teen (19) years and 3 months preg-nant was walking out of the lock-up to the other room, Evidently she wasn't walking fast enough. The fasclat pigs started to push her, the pig knocked her down and kicked has to the best and stamashed.

then moved her into the room and made her stay there till she was transferred later that night to the Super Fasciat Fig station at 11th and State Streets. The Brothers remained at Wood Street Station. We left immediately for 11th St. Station, when we got there Sandra had been taken to Cook County Butcher Shop (hospital) for internal injuries. The sister's health was threatening mis-carriage and bleeding from the kindneys. She was not allowed any visitors and was placed under guard. The next morning everyone was released on beed except Sandra; charges were as follows:

Chicago Black Panther Party member sterling "Pinky" Jones, 17, was murdered in the Aligara Cardens area by an unknown assailant Thursday sevening, December 25, when he answered the door of an apartment.

Many questions are unanswered as to who committed the murder and why, but one thing is for sure, that by murdering Sterling Jones, a people's warrior and a people's servant was taken. This was the same person who worked in the Breakfast for Children Program, who coursed his energies into the liberation of the oppressed. And the taking of his life was the highest the most despicable, and most offensive crime. crime.

The murderer gave no warning as the door was opened but fired directly into the eye of Pinky, and then fled into the night. Such as arch-criminal insults the streets

FOOD FOR CAIRO ILLINOIS

"Cairo represents the reality that is America in its rawest form" Rev. Charles Koen

The statement by the Reverend Charles Koen is not a romantic notion dreamed up by him; it is instead a concrete analysis of conditions that exist in Cairo, Illinois, The Black community of Cairo has been subjected to more than 154 racist attacks since March 31st, of 1969 by the fascist "White Hat" vigilante organization, which has been aided in its attempts to commit genocide on the Black community of Cairo by the repressive State and Local police forces. The majority of these attacks have been focused on the Pyramid Courts project area, many of whose all-Black population are United Front for Survival members, an organization formed for the purpose of dealing with the problems that face the Black community of Cairo, due to racism and exploitation on the part of White businessmen.

In April, 1969, the United Front, under the leadership of Rev. Koen, started an economic boycott of the white store owners in the downtown area of Calro. One of the stipulations for the ending of the boycott was that the racist White Hats cease their attacks on the black community of Cairo and disband at once, This was not done because the majority of the white citizenry of Cairo supports the White Hats and the racist city government and, would rather see the downtown area of Cairo in complete economic ruin rather than see their racist viligante groups disband, The result of the Black's economic boycott was intensification of the attacks upon them by police and night riders,

There has even been an effort on the part of the city government of starve the people into submission, by blocking routes to food stores outside of Catro. The Black Panther Party, recognizing that the struggle of the black community in Cairo is the struggle of oppressed people the world over, organized a Food Drive for the benefit of the suffering Black masses in that southern Illinois city.

From the beginning the food drive

was mer with an overwhelmingly positive response on the part of the Chicago community, which donated food and clothing by the carloads for the Black residents of Cairo. On May lith, comrades in the Illinois Chapter of the Black Panther Party rented a truck to take the donated food and clothes to the people of Cairo. When they got there, they saw the validity in calling that city "The front line



war zone of Black People". Two nights prior to the arrival of the truck there had been shoot-outs between the Black residents of Pyramid Courts and the racist white hats and police. The following is an excerpt from a press release from the United Front on that incident:



"Well over 1,500 rounds of ammunition were fired by local police and vigilantes in Cairo Sunday evening and early Monday morning (May 9 and 10). This was the second consecutive night of heavy firing into the Black Community by the whites, It is believed that these shootings are led by the recently elected city councilman and police commissioner, Mr. James Dale. The shooting lasted from 9:15 p.m. Saturday night until 3:00 a.m.; and from 10:00 p.m. Sunday night until 2:45 a,m. Although buildings were hit, there have been no reported injuries to Black residents of all-Black Pyramid Court, which sustained the bulk of the violence. Other predominately Black areas of the city of Calro were scenes of the white instigated violence."

When the comrades from the Black Panther Party arrived, they received a revolutionary welcome from representatives of the United Front and the Black community in general. They were also escorted around Pyramid Court and the outlying area, where they saw the visible evidence of the repression brought down on the Black people of Cairo, such as bullet holes from the attackers' .357 magnums, carbines, and 50 caliber machine



guns. These bullet holes were numerous throughout the Black community; they were in the homes, churches and headquarters of the United Front, testifying to the genocidal plot of the racist city government and vigilante groups.

The judicial system of Cairo is indicative of the overall conditions that exist for Black People there. There is currently a case in Cairo in which four brothers are being charged with two counts of aggravated battery. The prosecution says that on the afternoon of August 8th, during a United Front boycott of white downtown establishments, James Wilson, Herman and Wallace Whitfield, and Frank Washington attacked a white man named Carl Helt, who is the publisher and editor of the racist Calro "Tri-State Informer" newspaper. Carl Helt is also president of the fascist United Citizens for Community Action organization, which is based in Jackson, Mississippi, and an affiliate of the Ku Klux Klan,

The Black community of Carlo says that Carl Helt was never attacked by the four brothers. To substantiate this, a film was shown in court that gave undeniable evidence that pig Helt was not attacked on August 8th, 1970, The film was taken when the incident was supposed to have happened and it clearly shows that Carl Helt and his racist friends were lying. The whole trial itself is nothing more than a plan on the part of the Cairo city government to destroy the revolutionary fervor of the United Front in particular and the Black community in general,

The Cairo experience is best summed up in the words of a 65-year old Black sister whom the Black Panther Party interviewed. In the interview she stated that, "In Cairo, even the cows are racist," She further stated that for the salvation of the Black community of Cairo, it would take the concerted efforts of all progressive people throughout the United States.

In this vein, the Black Panther Party calls on all concerned people to continually send food and clothing for Cairo to our offices in the Chicago area, Our offices are located at 4233 S. Indiana and 2350 W. Madison, ALL POWER TO THE PEOPLE
