FEMALE PANTHER TORTURED

Jaan Bird was taken into custody at 9:00 P.M. on January 17, 1969 after several shots had been fired at two pigs. She was beaten and tortured all night and morning. At 4:00 P.M., January 18, 1969, she was brought before Judge Tyler of the criminal court of New York where she was held as a material witness. At approximately 10:00 P.M. the following day (after 25 hours of detainment) was arraigned on the following charges, 1. Assault with the intent to commit murder and 2. attempted murder.
Joan appeared in pain, as she

had many apparent injuries; swol-len eye, severly bruised forehead, swollen lip, and numerous cuts and bruises.

Sister Bird is 19 years old and a student nurse at Bronx Com-munity College, A Brother, Lt. Lumbia, went to the 34th pre-cinct along with his lawyer, to inquire about the safety of Sister Bird. For this, he was promptly arrested. He was arraigned, along with Joan in night court with conspiracy to commit murder and were placed under \$20,000
